ORDER:-

The Tamil Nadu Private Universities Act, 2019 (Tamil Nadu Act 14 of 2019) has been enacted and the same has been brought into force on 08.07.2019 and the Tamil Nadu Private University Rules, 2019 has also been notified in the Tamil Nadu Government Gazette Extraordinary on 08.07.2019.

2. The sponsoring body viz. Selvam Educational and Charitable Trust, Raja Nagar, Vadakkangulam in the letter second read above has submitted a detailed proposal for establishment of a Private University in the name of "Joy University" at Raja Nagar, Vadakkangulam, Tirunelveli along with the Challan receipt for Rs.12,00,000/-, dated 08.02.2021.

3. Based on the reports of the Expert Committee constituted vide Government letter third read above, the Government in the letter fourth read above, issued Letter of Intent, informing the sponsoring body viz. Selvam Educational and Charitable Trust, the Intent of the Government to permit establishment of a Private University by the name "Joy University" at Raja Nagar, Vadakkangulam, Tirunelveli District subject to fulfillment of the conditions stipulated in section 4 of the said Act and all other conditions or requirements as stipulated in that Act and the Rules made thereunder.

4. The Chairman, Selvam Educational and Charitable Trust, Raja Nagar, Vadakkangulam in his letter fifth read above has stated that all requirements of section 4 of the Act have been fulfilled and also stated that the Board of Trustees of the Trust at its meeting held on 5th February 2020, has passed a resolution to establish a Private University and allocated 100.40 acres of land at Alaganeri Village, Radhapuram Taluk, Tirunelveli District and fifty percent of the Permanent Endowment Fund i.e sum of Rs.25,15,00,000/- (Rupees Twenty five crore and fifteen lakh only) has been deposited in the name of Selvam Educational and Charitable Trust and enclosed a copy of the fixed deposit receipts.

5. The Chairman, Selvam Educational and Charitable Trust, Raja Nagar, Vadakkangulam has, therefore, requested the Government to make necessary arrangements to include the name of the University viz. "Joy University" in the Schedule of the Tamil Nadu Private Universities Act, 2019 and pass appropriate orders at the earliest.

6. The Government have examined the proposal of the Chairman, Selvam Educational and Charitable Trust, Raja Nagar, Vadakkangulam in para 5 above and decided to include the name of the University viz. "Joy University" in the Schedule of the Tamil Nadu Private Universities Act, 2019 with the details of location, by way of amendment to the Schedule, as per section 9 of the said Act.

7. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette Extraordinary:-

NOTIFICATION.

In exercise of the powers conferred by section 9 of the Tamil Nadu Private Universities Act, 2019 (Tamil Nadu Act No. 14 of 2019), the Governor of Tamil Nadu hereby makes the following amendment to the Schedule to the Act :-



Sir,

Sub : Higher Education – Private Universities – Established in Tamil Nadu through Notification – To take action for the incorporation of the University either through a separate Act or the amendment in the schedule by the Act of the State Legislature so as to include them in the UGC list of Universities as per the section 2 (f) of the UGC Act, 1956 – Requested – Regarding.

Ref : 1. The Tamil Nadu Private Universities Act, 2019 (Tamil Nadu Act No.14 of 2019).
2. Your letter F.No:8-8/2022 (CPP-I/PU) dated. 02.08.2022.
3. Your letter F.No:8-12/2021 (CPP-I/PU) dated. 08.08.2022.

I am directed to invite attention to the references cited.

2. In the letters second and third cited, it is stated that the State Government of Tamil Nadu vide Gazette Notification No:125 & 126 dated:26.02.2021, under powers conferred by section 9 of the Tamil Nadu Private Universities Act 2019 (Act No:14 of 2019) has amended the schedule and included the name for establishment of Sri Venkateswaraa University and NMV University, Tamil Nadu and informed that as per section 2 (f) of UGC Act 1956, the University can either be established by the Act of the Parliament or by the Act of the State Legislature.

3. It is also stated therein that the Hon'ble Supreme Court of India in its order in Prof. Yashpal Vs. The State of Chhattisgarh and Ors. has struck down clauses whereby the State Government can establish a university by Notification. It has also been stated that the NMV University and Sri Venkateswaraa University

have been established by amendment in the schedule by the State Government and they were neither established by a separate Act nor by an amendment in the schedule by the Act of the State Legislature. You have therefore requested this Government to take necessary action for the incorporation of the University either through a separate Act or the amendment in the schedule by the Act of the State Legislature, since the amendment in the schedule should be by the State Legislature and not by the notification of the State Government.

4. In this connection, I am to point out that clause (f) of section 2 of the University Grants Commission Act, 1956 (Central Act 3 of 1956) defines the term "University" as follows :—

"University" means a University established or incorporated by or under a Central Act, a Provincial Act or a State Act and includes any such institution as may, in consultation with the University concerned, be recognized by the Commission in accordance with the regulations made in this behalf, under this Act.

As per the above provision, a University can either be established by an Act or incorporated under an Act.

Further, I am to point out that sub-section (1) of section 5 of the Chhattisgarh Niji Kshetra Vishwavidyalaya (Sathapara Avr Viniyaman) Adhiniyam Act, 2001 provides that the State Government may by notification in the Gazette establish a University by such name and with such jurisdiction and location of campus as may be specified therein. The said Section empowers the **State Government of Chhattisgarh**, to establish a University **simply by issuing a notification in the official Gazette**. In view of the above, the Supreme Court has struck down Section 5 of the said Chhattisgarh Act, for the reason that the said section is not in consonance with Section 2 (f) of the UGC Act, 1956.

5. On the other hand, section 9 of the Tamil Nadu Private Universities Act, 2019 (Tamil Nadu Act 14 of 2019) provides that the Government shall include the name of the University in the Schedule with details of location by way of an amendment in the Schedule, after satisfying that the sponsoring body has fulfilled the condition of letter of intent". Section 9 of the said Act is in fact a delegation of the legislative power of the State Legislature to the State Government to amend the Schedule of the said Act and it is legally sustainable. An amendment issued under the said section 9 to the Schedule to the said Act shall have equal force of law as that of an amendment made by the State legislature itself and it is not correct to state that an amendment to the Schedule to an Act shall be made by way of an amending Act alone.

6. As per the said Tamil Nadu Act 14 of 2019, the private Universities have got incorporated in the Schedule of the said Act by an amendment to the said Schedule through a statutory Notification published in the Government Gazette and it is legally valid. As such, the private Universities established under the said Tamil Nadu Act 14 of 2019 have actually got incorporated in the said Tamil Nadu Act, once the name of the private University is included in the Schedule by way of an Amendment to the said Act through a Notification published in the Tamil Nadu Government Gazette.

7. Hence, section 9 of the said Tamil Nadu Act 14 of 2019 is not comparable to section 5 of the said Chhattisgarh Act, since the Private Universities established under the said Tamil Nadu Act actually got incorporated in the said Act as stipulated in the University Grants Commission Act, 1956, whereas section 5 of the said Chhattisgarh Act does not provide for such incorporation and under the said Chhattisgarh Act, 2001, the private Universities were established merely through a notification alone. Hence the decision of the apex Court in Yashpal's case is not squarely applicable to section 9 of the said Tamil Nadu Act.

8. In fact in Professor Yashpal's case, the apex court has recognized the establishment of Universities by way of incorporation under a compendious Act and it does not stipulate that an University shall be establish by way of a separate Act only. The Apex Court has also taken into account the subsequent amendment made to the said Chhattisgarh Act, providing for incorporation of the universities in the said Act and has declined to accept the same, only in view of the fact that the Private Universities have already been established by way of an executive order.

9. The relevant observation of the Supreme Court is as under :-

"In view of Regulation 3.1, a Private University can only be established either by a separate Act or by one compendious Act, where the legislature specifically provides for establishment of the said University. Though an attempt has been made in section 5 (1) (b) of the amended Act in this regard, but the same does not conform to the regulations inasmuch as the initial notification notifying in the official gazette that the University is established is done by the executive order and not by any Act of legislature."

10. Whereas, in the case of the said Tamil Nadu Act 14 of 2019, the 7 private Universities had been incorporated under the said Act, which is a compendious Act, by way of a Notification under section 9 of the said Act and hence the establishment of the said Private Universities are only in accordance with the said decision of the Supreme Court in professor Yashpal's case.

11. Apart from the above the apex court has struck down sections 5 and 6 of the said Chhattisgarh Act on the ground that more than 112 Universities were established in a mechanical manner within a short span without satisfying the infrastructural facilities and teaching facilities of those Universities. Moreover, the Supreme Court while striking down sections 5 and 6 of the said Chhattisgarh Act has observed as follows:-

"the whole scheme of the impugned Act, especially the effect of Sections 4,5,6 thereof and the result which it has led to in notifying as many as 112 Universities within a short span of one year on the basis of proposals made on paper with many or most of them having almost zero infrastructural facilities, clearly shows that the relevant provisions of the Act have completely stultified the power of the Parliament under Entry 66 to make provision for co-ordination and determination of standards in institutions for higher education like Universities, the provisions of the UGC Act and also the functioning of University Grants Commission. Sections 5 and 6 of the impugned Act are therefore, wholly ultra vires the Constitution of India and are liable to be struck down".

12. I am further to state that as far as Tamil Nadu Private Universities Act, 2019 (Tamil Nadu Act 14 of 2019) is concerned, there are provisions such as sections 4 to 9, which ensure that the Private Universities have been properly established by following relevant provisions of the University Grants Commission Act and other requirements of the University such as infrastructure, teaching faculty, other financial resources, etc. Further, only 7 private universities have so far been incorporated under the said Tamil Nadu Act by way of amendments to the schedule to the said Act. It may, therefore, be stated that unlike in the case of Chhattisgarh Act, the said 7 private Universities have been established after proper verification and such establishment of private universities in the State of Tamil Nadu was not made in an indiscriminate and mechanical manner. On this ground also, the decision of the Supreme Court in Professor Yashpal's case is not squarely applicable to the private universities established under the said Tamil Nadu Private Universities Act, 2019. Therefore, the establishment of the private Universities under section 9 of the Tamil Nadu Private Universities Act, 2019 by incorporating them in the Schedule to the said Act by way of statutory Notifications is legally valid and is not hit by the decision in Professor Yashpal's case.

13. In view of the position stated above, I am also to inform that the establishment of the Private Universities under section 9 of the Tamil Nadu Private Universities Act, 2019 by incorporating them in the Schedule to the said Act by way of statutory notification is in order and hence the question of establishing of the said 7 private Universities through a separate Act of the State legislature or incorporating the said Private Universities in the schedule of the Tamil Nadu Private Universities Act, 2019 (Tamil Nadu Act 14 of 2019), **by amending the schedule of the said Act**, by an Act of the State Legislature, does not arise.

14. I am therefore to request you to take necessary action to include the name of the 7 private Universities viz. Dhanalakshmi Srinivasan University, Sree Anusuya University, Sri Venkateswaraa University, NMV University, Jeppiaar University, Takshashila University and Joy University in the UGC list of University as Private Universities.

Under Rule 130 of the Tamil Nadu Legislative Assembly Rules, the following Bill which was introduced in the Legislative Assembly of the Tamil Nadu on 9th December, 2024 is published together with Statement of Objects and Reasons for general information:—

L.A Bill No. 43 of 2024

A Bill to Amend the Tamil Nadu Private Universities Act, 2019.

BE it enacted by the Legislative Assembly of the State of Tamil Nadu in the Seventy-fifth Year of the Republic of India as follows:—

1. (1) This Act may be called the Tamil Nadu Private Universities (Amendment) Act, 2024.	Short title and commencement.
(2)(a) All sections except section 5 shall come into force at once.	
(b) Section 5 shall be deemed to have come into force, —	
(i) with effect from the 20th day of January 2021, insofar as it relates to entries against Serial Number 1 of the Schedule;	
(ii) with effect from the 25th day of February 2021, insofar as it relates to entries against Serial Number 2 of the Schedule;	
(iii) with effect from the 26th day of February 2021, insofar as it relates to entries against Serial Numbers 3, 4 and 5 of the Schedule;	
(iv) with effect from the 27th day of May 2022, insofar as it relates to entries against Serial Number 6 of the Schedule;	
(v) with effect from the 26th day of July 2022, insofar as it relates to entries against Serial Number 7 of the Schedule; and	
(vi) with effect from the 15th day of March 2024, insofar as it relates to entries against Serial Number 8 of the Schedule.	
Tamil Nadu Act 14 of 2019.	2. In section 2 of the Tamil Nadu Private Universities Act, 2019 (hereinafter referred to as the principal Act),—
(1) clause (r) shall be omitted;	
(2) after clause (t), the following clause shall be inserted, namely:—	
“(tt) “NMC” means the National Medical Commission constituted under the National Medical Commission Act, 2019 (Central Act 30 of 2019);”;	
(3) for clause (w), the following clause shall be substituted, namely:—	
“(w) “Private University” means a University established under section 9;”;	
(4) in clause (y), for the expression “MCI”, the expression “NMC” shall be substituted.

3. In section 3 of the principal Act, for sub-section (1), the following sub-section shall be substituted, namely:—

“(1) The Government may permit the establishment of a Private University by any sponsoring body by way of an Act of State Legislature.”.

“9. Inclusion of Private University in the Schedule.—Upon satisfaction of the Government that the sponsoring body has fulfilled the conditions of Letter of Intent, the name of the Private University along with the details of its location and its sponsoring body shall be included in the Schedule by way of an Act of the State Legislature.”.

Notwithstanding anything contained in any judgment, decree or order of any Court or other authority, all acts, proceedings or things done or taken in pursuance of Notification No.II(2)/HE/53(a)/2021, published in Part II-Section 2 of the *Tamil Nadu Government Gazette* Extraordinary, dated the 20th day of January 2021, Notification No.II(2)/HE/132(c)/2021, published in Part II-Section 2 of the *Tamil Nadu Government Gazette* Extraordinary, dated the 25th day of February 2021, Notification No.II(2)/HE/132(i) /2021, published in Part II-Section 2 of the *Tamil Nadu Government Gazette* Extraordinary, dated the 26th day of February 2021, Notification No.II(2)/HE/132(j)/2021, published in Part II-Section 2 of the *Tamil Nadu Government Gazette* Extraordinary, dated the 26th day of February 2021, Notification No.II(2)/HE/132(k)/2021, published in Part II-Section 2 of the *Tamil Nadu Government Gazette* Extraordinary, dated the 26th day of February 2021, Notification No.II(2)/HE/411(f)/2022, published in Part II-Section 2 of the *Tamil Nadu Government Gazette* Extraordinary, dated the 27th May 2022, Notification No.II(2)/HE/609(c)/2022, published in Part II-Section 2 of the *Tamil Nadu Government Gazette* Extraordinary, dated the 26th day of July 2022 and Notification No.II(2)/HE/185(d)/2024, published in Part II-Section 2 of the *Tamil Nadu Government Gazette* Extraordinary, dated the 15th day of March 2024, from the date of publication of the above said notifications till the date of the publication of this Act in the *Tamil Nadu Government Gazette*, shall, for all purposes, be deemed to be, and to have always been, validly done or taken in accordance with law as if the Schedule as so substituted by section 5 had been in force at all material times when such acts or proceedings were done or taken.

STATEMENT OF OBJECTS AND REASONS.

The Tamil Nadu Private Universities Act, 2019 (Tamil Nadu Act 14 of 2019) enables the Government to permit the establishment of a Private University by any sponsoring body, by inclusion of the name of the University, its location and the details of the sponsoring body in the Schedule to the said Act. Section 9 of the said Act provides for amending the Schedule by the Government to include a private university, after satisfying that the sponsoring body has fulfilled the conditions of Letter of Intent. Accordingly, so far eight private universities have been included in the Schedule by amending it, by way of notifications.

2. The University Grants Commission has stated that as per section 2(f) of the University Grants Commission Act, 1956 (Central Act III of 1956), a university can either be established by the Act of the Parliament or by the Act of the State Legislature. It has also stated that the amendment to Schedule should be made by an Act of the State Legislature and not by issue of notification by the State Government. The University Grants Commission has, therefore, requested to get the aforesaid private universities to be established by including their names in the Schedule through an Act of the State Legislature.

3. In view of the above, it has been decided to amend the Tamil Nadu Private Universities Act, 2019 (Tamil Nadu Act 14 of 2019) suitably for inclusion of the said eight private universities in the Schedule to that Act and to suitably amend certain other provisions of the said Act in tune with the suggestions of the University Grants Commission.

4. The Bill seeks to give effect to the above decision.


